Raw fruits and vegetables (except for legumes), Aluminum foil, Plastic Wrap, and Bags that are certified Kosher for the whole year are acceptable on Passover with the O-U.

Any 100% pure cocoa in new box

Plastic plates, Styrofoam

**Fish** (frozen, raw, uncoated only)

**Fruit & Fruit Products**

All frozen unsweetened additive-free whole, sliced or formed frozen fruit (e.g. sliced peaches, melon balls, blueberries, strawberries) without syrup.

All 100% Pure unsweetened frozen orange or grapefruit juice

Whole, raw without BHA & BHT

(Midget Pecans & Pecan Pieces require Passover certification)

**Olive Oil**

Extra virgin olive oil

**Oven Cleaner**

Dow, Easy Off, Mr. Muscle

**Poultry**

All Kosher raw meat & poultry with reliable kosher supervision. (Empire raw turkey burgers must have OUP)

**Raisins**

Any with OU

**Salt**

Any non-iodized salt without dextrose, maltodextrin or polysorbates

**Scouring Pads**

Chore Boy, O'Cel-O, Scotch Brite, Scrunge

**Silver Polish, Copper & Metal Cleansers**

Hagerty metal cleaner with OU

Require Passover certification.
