#### KOSHER KANSAS CITY IS GROWING! – A MESSAGE FROM OUR EXECUTIVE DIRECTOR

Interest in Kosher continues to grow both locally and across the country. On average, supermarkets in the U.S. carry over 19,000 kosher products. Kosher food companies are growing at a rate of 10-15% annually. Add to that nationally recognized list several new accounts certified by the Vaad HaKashruth of Kansas City, including but not limited to The Roasterie, Boulevard Brewing Company, Askinoisie Chocolates, the Date Lady and Hilary's Eat Well.

Besides servicing the food production industry, the Vaad HaKashruth of Kansas City supervised kosher dining out events at Princess Gardens, Johnny Brusco's New York Style Pizza, the Hy-Vee at 95<sup>th</sup>, the Westport Flea Market and Oakwood Country Club this past year. These kinds of events promote all-inclusive activities to be enjoyed by the entire Kansas City community.

The Vaad contributes to kosher food opportunities throughout the area through oversight at the Rams Café, Village Shalom/Rachel's Café and the KC Kosher Meals-on-Wheels program. Behind the scenes, the Vaad supervised numerous weddings, bar and bat mitzvahs, and congregational events around the city.

In August, 2013, the 2<sup>nd</sup> Annual Vaad HaKashruth Kosher BBQ Festival was

held on the grounds of Congregation B'nai Jehudah, with increased attendance, more teams competing, and a Food Network celebrity judge participating. Every congregation in the city was represented through either volunteers or festival goers. Exciting plans are already underway for the 3<sup>rd</sup> Annual KC Kosher BBQ Festival, set for August 17, 2014 at the Ritz Charles Overland Park. As we approach Passover, proper adherence to the halachot (laws) of Pesach is of primary concern for the Vaad HaKashruth of Kansas City and for Jews throughout our community. ## What to Look for On the Package

Look before you leap! In other words,

be sure to take a careful look at the product packaging before purchasing. Mistakes are made in grocery stores with products ending up on Passover shelves that don't belong there. Many products that are kosher year round have similar certifications for Passover.

Look carefully before your purchase!
Kosher for Passover store stickers
found on products should not be
assumed to be an accurate indication
of Kosher for Passover certification
due to possible mislabeling at the
store level.

With that in mind, you will find It impossible to cover each and every product which may contain chametz. Shopping for Pesach is a special undertaking requiring care and attention.

Look carefully when purchasing Israeli products as many are labelled Kitniyot, which is acceptable only for those individuals observing Sephardic customs.

One must ascertain that any processed food has been properly supervised and certified by an acceptable kosher supervisory agency or rabbinic authority.

Look for the "P" designation after the hechsher. "P" is for Passover, not pareve.

# Pre-Pesach Cleaning List Disposal of Chametz Check List

### Did you remember to ...

- ...check your medicine cabinet for sprays,
  - toiletries, and cosmetics including mouthwash, that are not recommended for Passover use?
  - ...thoroughly clean and wash the playpen, including padding, as well as the high chair and crib, carriages and strollers, as well as toy boxes?

- ...make certain that your pets are not fed chametz during Passover?
- ...turn your children's pockets inside-out to shake out all the crumbs, see that all family members do the same with their clothes?

  (Women should also be careful not to leave candy, gum, or chametz cosmetics in their purses.)
- ...thoroughly clean the glove compartment of the car, and vacuum all the surfaces on the inside of the front and the back seats, as well as the trunk?

- ...meticulously clean your kitchen area, stove, cupboards, refrigerator, table top, shelves, sink, etc.?
- ...kasher any utensils or silverware before Monday, April 14th, 2014 at 12:01p.m.?
- ...check the drawers, filing cabinets, etc. in your office, as well as in your house, for chametz you may have forgotten?
- ...replace all vacuum cleaner bags?

## Items That Are Acceptable Without Passover Certification

#### Aluminum products:

Foil and pans all are acceptable without Passover certification.

#### Charcoal:

Acceptable without Passover certification Cocoa Powder: if 100% Pure and not processed in Europe (All Hershey's are acceptable)

#### Coffee:

Beans which are plain, unflavored, and not decaffeinated do not require certification, but the grinder must be clean instant, flavored or decaffeinated coffee requires certification.

K-cups require certification.

#### Extra Virgin Olive Oil (unflavored):

Acceptable without Passover certification.

#### **Extra Virgin Coconut Oil:**

Spectrum Brand is Acceptable with a plain OU.

#### Milk:

Should have Kosher for Passover Certification, if there is none available regular milk may be purchased prior to Passover.

#### Meat:

Any fresh or frozen in the original packaging are acceptable unless its ground and then it would need a Kosher for Passover symbol.

#### Plastic Wrap:

Acceptable without Passover certification.

#### Plastic and paper plates:

Acceptable without Passover certification.

#### Salmon (and other kosher skin on fish):

Fresh is acceptable however canned, frozen or processed needs Passover certification.

#### Salt:

Acceptable without lodine or other additives.
