FAQ Anise – Same Status as *Kitniyos*

Q The cRc shopping guide lists a few varieties of anise (caraway, cumin, coriander, dill, and fennel) as *kitniyos*. Can you explain to me why that is the case?

A *Rema* 453:1 rules that anise and coriander are not *kitniyos*. Some of the later *poskim* (*Taz* 453:1 & 462:3, and *Chok Yaakov* 453:9) basically accept this *psak* but suggest that these spices be checked carefully to make sure none of the five grains are mixed into them. Other *poskim* (*Magen Avraham* 453:3) take a stricter approach and are of the opinion that one should avoid these spices since it is so difficult to check whether grains are mixed into them. Rav Schwartz *zt"l* accepted the ruling of the *Mishnah Berurah* 453:13 to follow the stricter approach. Accordingly, these spices are listed in our shopping guide as “same status as *kitniyos*.”



KASHERING THE KITCHEN

Counters, Sinks, and Tables

One may not *kasher* surfaces made of porcelain, ceramic, cement, or glass, but can *kasher* stainless steel, stone, marble, quartz, plastic/laminate, or wood if there are no cracks, nicks, or scratches where food might be stuck. Some additional materials are listed in the coming pages, and more details are available by scanning the QR code below.

To *kasher* these surfaces, clean them thoroughly, don't use them for 24 hours, boil a kettle of water, and carefully pour that water over all surfaces. Want to use a steamer? Scan the QR code. Some have a custom to cover these surfaces for Pesach even after *kashering* them, and "covering" is the only option if a sink, counter, or table is not suitable for *kashering*. [For sinks, aside from *kashering*, replace the strainer covering the drain and the aerator on the faucet, and if there is a coiled hose, do not pull it out of its base during Pesach.]

Cups

Most cups cannot be *kashered*, since they are made of glass, china, or ceramic. Metal or plastic cups that are not scratched can be *kashered* like flatware.

Flatware

Clean them well, don't use them for 24 hours, submerge one piece at a time in boiling water, and then rinse with cold water.

Microwave Oven

The glass plate cannot be *kashered* and must be removed. To *kasher* chamber, clean thoroughly, do not use for 24 hours, and then place a bowl of water in the chamber and boil it for 10-15 minutes. It is commendable to cover food on Pesach, even if the microwave was *kashered*.

Oven

Run a full self-clean cycle. [Low-temperature self-clean cycles (e.g., AquaLift) do not qualify as a *kashering*.] If self-clean is not an option, clean thoroughly, do not use for 24 hours, and then set oven to 550°F for one hour. Scan the QR code below for details.

Refrigerator and Freezer

Clean thoroughly and line with plastic or foil that is perforated to allow for air circulation.

Stovetop

Clean surfaces and grates well, do not use for 24 hours, and then turn on the flame or coil to its highest setting for 30 minutes. [15 minutes is enough for exposed electric coils.] This is also effective for glass-covered stovetops (it is advisable not to *kasher* more than two burners at a time). After *kashering*, cover the knobs, catch trays, all areas **between** the burners, and any areas **behind** the burners where pots might touch.

Induction stovetops cannot be *kashered*, and pots should be put onto "induction discs" during Pesach.

Tablecloths

Fabric tablecloths may be used for Pesach after being laundered. Vinyl/plastic tablecloths **cannot** be *kashered*.

Other

Dishwashers cannot be *kashered* for Pesach. For warming drawers, pots, and other items not listed here, scan the QR code below.

COUNTERTOPS

Countertops may be *kashered* for Pesach and year-round using *irui kli rishon*. This involves cleaning the counter thoroughly, not using it for 24 hours, boiling a kettle of water, and methodically pouring that water over all surfaces. [Some have a custom to cover counters even after they are *kashered*.] Two types of countertops cannot be *kashered*:

Those made of certain materials. These are shaded orange and marked as not *kasherable* in the chart.

Those which have scratches, stains, or seams where food might be trapped. Materials which are more prone to that concern are shaded yellow and marked with a star ("*") in the chart.

The items listed as requiring *tevillah* are based on an assumption that they are made from metal or glass and used in the standard manner.

C. Perform *tevillah* but do not recite a *bracha*.

MEDICINES, COSMETICS & TOILETRIES FOR PESACH

NOTE: THIS LETTER REFERS TO PESACH-SPECIFIC CONCERNS.
PLEASE CONSULT YOUR RABBI REGARDING THE USE OF MEDICINES, COSMETICS,
AND TOILETRIES ON *SHABBOS* AND *YOM TOV*.

MEDICINES

- All pill or non-chewable tablet medication – with or without *chametz* – that one swallows is permitted. [Candy-coated pills are an exception to this rule, but they are quite uncommon.] Vitamins and food supplements do not necessarily fall into this category, and each person should consult with their Rabbi.
- Gelcaps, both hard and soft, do not pose a *chametz* concern, but the gelatin they are made from is not kosher. Accordingly, during *Pesach* and all year-round, they should only be consumed by someone who is ill and does not have an alternative medicine which is free of *kashrus* concerns.
- Liquid and chewable medications that may contain *chametz* should only be used under the direction of a doctor and Rabbi, who will judge the severity of the illness, the likelihood that the medicine contains *chametz*, and the possibility of substituting a swallowable pill.

Important: Do not discontinue use of liquid, chewable or any other medicine without consulting with your doctor and Rabbi.

- Liquid and chewable medications that contain *kitnios* may be consumed by someone who is ill. An otherwise healthy person, who would like to consume a liquid or chewable medicine to relieve a minor discomfort, should only do so if the product is known to be free of *kitnios*.

COSMETICS & TOILETRIES

- All varieties of blush, body soap, conditioners, creams, eye shadow, eyeliner, foundations, ink, lotions, mascara, nail polish, ointments, paint, shampoo, and stick deodorant are permitted for use on *Pesach* – regardless of the ingredients contained within them.
- Many varieties of cologne, liquid deodorants, hairspray, mousse, perfume, shaving lotion, sunscreen, and wipes contain denatured alcohol, and therefore should only be used on *Pesach* if they do not contain alcohol or the alcohol is known to be free of *chametz*. Such products manufactured in the United States may be used, regardless of whether the ingredient list includes denatured alcohol.
- Lipstick, mouthwash, and toothpaste which contain *chametz* should not be used.

Medicine Guidelines

The cRc's general guidelines on medicines, cosmetics, and toiletries can be found on the previous page. The following is a summary of the medicine portion of those guidelines:

All **pill medication**, in solid tablet or solid caplet form – with or without *chametz* – that one swallows is permitted. (Candy-coated pills are an exception to this rule, but they are quite uncommon.)

Vitamins generally do not qualify as medications and are instead treated as food supplements which require *hashgachah* for Pesach. If a doctor prescribes a specific vitamin which does not have Pesach supervision, please review your specific situation with your doctor and rabbi.

Gelcaps, both hard and soft, do not pose a *chametz* concern, but the gelatin they are made from is not kosher. Accordingly, during Pesach and all year round, they should only be consumed by someone who is ill and does not have an alternate medicine which is free of kashrus concerns.

Liquid and chewable medications that may contain *chametz* should only be used under the direction of a doctor and rabbi, who will judge the severity of the illness, the likelihood that the medicine contains *chametz*, and the possibility of substituting a swallowable pill. **Important: Do not discontinue use of liquid, chewable, or any other medicine without consulting with your doctor and rabbi.**

Liquid and chewable medications that contain *kitniyos* may be consumed by someone who is ill.

For laws of taking medicine on Shabbos and Yom Tov, please consult your Rabbi.

Medicine and Toiletry Details

Items marked “Possible *chametz*” contain edible ingredients whose *chametz*-status we were unable to determine; these items may be permitted for someone who is seriously ill, and consumers should consult with their rabbi.

Antibiotics

Generally speaking, the cRc recommends all medicinal items in pill form, which includes most of the antibiotics that adults take. The same does not apply when dealing with liquid or chewable medicines, which are considered “edible.” Since there is a chance that they contain *chametz*, they should only be used if they are known to be free of any concerns.

However, antibiotics are an exception to that rule. Generally, antibiotics are given to treat ailments which, if left untreated, can lead to a situation of *sakanah* (danger to life). Therefore, one may consume antibiotics regardless of the ingredients used in creating them.

Each year, the cRc researches different fever-reducers and pain relievers to see which are suitable for use on Pesach. Some of the results are ready in time for inclusion in the printed cRc Pesach Guide, and some others can only be found in the cRc app, or at www.ASKcRc.org.

FAQ Coated Pills

Q It says on your website that one can take any pill medication that is swallowed. Does that include coated pills such as Advil?

A Most pills which are meant to be swallowed are coated with a glaze, wax, or shellac, which makes the pills easier to swallow, and some of these coatings have some form of simple sugar (e.g., sucrose). None of these ingredients are problematic for Pesach.

In rare cases, though, a pill has a flavor or is coated with sweeteners which are Pesach-sensitive (e.g., sorbitol or mannitol). These are listed as inactive ingredients, and we don't recommend them for Pesach. One example of this is some Advil brand products. The inactive ingredient panel occasionally lists that the coating contains mannitol or a flavor, and those items are not recommended.



FRUIT & VEGETABLE BUG CHECKING GUIDE

A Sampling

Below you will find the current cRc position on a few popular items. Infestation levels change due to numerous factors, including seasons, growing environments, and global imports; therefore, the cRc constantly reviews its policies and cleaning methodologies. The instructions noted below represent the most updated information as of the printing of this guide. For current information, please search at www.ASKcRc.org. For instructions on the thrip-cloth method, see next page.

Asparagus

FRESH GREEN ASPARAGUS must have the tips cut off and discarded. One should either peel the entire sides of the asparagus or remove all the triangular side leaves and wash well. **CANNED** are permissible only with a reliable kosher certification. **FROZEN** are only permissible with reliable kosher certification or if one follows the steps above. **FRESH WHITE ASPARAGUS** can be used after simply rinsing it well.

Bell Peppers

All **BELL PEPPERS** must have the crown/stem area removed and the rest of the outside of the pepper rinsed and rubbed (especially in the grooves) under running water. This is true for **MINI PEPPERS** as well. They may not be roasted whole. The crown/stem area must be chopped off, and then washed and rubbed very well.

Blueberries, fresh

Agitate the **BLUEBERRIES** in soapy water for a minute, and then agitate one more time in plain water. This does not apply to **ORGANIC** and **U-PICK BLUEBERRIES** which require the thrip-cloth method.

Celery Stalks

NON-ORGANIC – cut away and discard the leaves, then wash each stalk under a stream of water.

ORGANIC – cut away and discard the leaves, place the stalks in a bowl of soapy water, and then wash each stalk under a stream of water.

Endives, Belgian, fresh

Separate the leaves and wash each one individually under a stream of water.

Endives, fresh

Use cRc thrip-cloth method.

Fennel, fresh

FENNEL STALKS — Wash each stalk under a stream of water.

FENNEL BULB — Either check carefully between each layer or wash each layer off individually.

Garlic, fresh

Peel and rinse. Cloves need to be separated.

Grapes

Separate the large bunch of grapes into 3 or 4 smaller bunches and rinse under cold water.

Leeks

Cut along full length of the leek so every leaf is separated. Place into soapy water. Wash each leaf thoroughly under running water.

Lettuce, Romaine, fresh

Use cRc thrip-cloth method.

For **ROMAINE NON-ORGANIC HEARTS**, the following alternative method may be utilized:

1. Separate the leaves from the hearts, place them in a bowl of soapy water, and agitate for approximately one minute.
2. Remove lettuce from the soapy water and gently rub all areas of both sides of the leaves with a sponge (this includes flattening the curled up edges so that they can be scrubbed).
3. Rinse each leaf under running water, front and back, while running your fingers across the entire leaf to undo the folds.
4. Start again by putting the lettuce back into a fresh bowl of soapy water and agitate the leaves for about a minute.
5. Rinse each leaf under running water, front and back.

If this alternative method is not convenient, use cRc thrip-cloth method.

FAQ Vegetable Wash

Q Does vegetable wash require *hashgachah* for Pesach?

A Yes, it does. Although there are a few kosher vegetable washes on the market, to the best of our knowledge, none of them are certified for Pesach. You can substitute a small amount of dish liquid (any is acceptable) which will do the same job, if not better.

The cRc is proud to maintain a full database of common fruits and vegetables purchased in the United States and their respective proper checking methods. The full range of fruits and vegetables can be found by searching consumer.crc kosher.org/consumer/fruitsvegetables.



Mushrooms, fresh

STANDARD (BUTTON) FRESH MUSHROOMS can be used after they are washed well. For **PORTOBELLO MUSHROOMS**, make sure the washing includes the fan area. For **SHITAKE MUSHROOMS**, wash each one individually under a strong stream of water. **OYSTER, PORCINI**, and **MOREL MUSHROOMS** are not recommended.

Parsley and Other Herbs, fresh

Use cRc thrip-cloth method.

Scallions (green onions), raw

Check for leaf miners on the tubes/stems. If a leaf miner trail is found, then remove the entire trail.

Dice the entire scallion into small pieces. Place into a bowl of water with a little bit of soap, and agitate for approximately 30 seconds. Pour into a strainer and rinse.

Alternatively, slice the entire scallion across its length, and check carefully for insects.

Strawberries, fresh

1. Cut or pluck off green tops.
2. Place strawberries into a bowl of soapy water and strongly swish them around for about a minute. Water should be approximately the ratio of 8 cups of water to 1 tablespoon of (a non-fragranced) soap.
3. Remove soapy strawberries and place them into a bowl of plain water. Swish around for about 30 seconds to a minute.
4. Remove strawberries and place them into a new bowl of soapy water (see above for amount of soap) and swish them around again for about 30 seconds to a minute.
5. Rinse and enjoy.

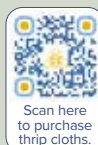
Please note that this does not apply to organic strawberries that are very difficult to get cleaned and therefore should be avoided at this time. Of course, if one wants to avoid the above steps, one can eat the strawberries (even organic) by simply cutting off the tops and peeling off the entire outside of the strawberries, followed by a rinse.

THRIP-CLOTH METHOD

Supplies

You will need a thrip cloth, light box, large bowl, dish soap, and 2 strainers.

Thrip cloths are fine silk cloths which filter insects from water; they are available for purchase from the cRc. Seventh Generation Free and Clear dish soap is a good choice for this procedure. cRc does not recommend the use of salt water or vinegar to properly remove insects from fruits and vegetables.



Procedure

1. Separate the leaves and place them into a bowl of water.
2. Put enough dish soap or kosher vegetable wash into the bowl until the water and leaves feel somewhat slippery.
3. Soak and agitate the leaves in the soapy water for 1-2 minutes.
4. Remove the leaves from the bowl and discard the water.
5. Repeat steps 2-4. Alternatively, put the leaves in a bowl of water to soak, and wash both sides of each leaf under running water.
6. Place leaves into a bowl of fresh soapy water and agitate for 1-2 minutes.
7. Remove leaves and pour the soapy water through a thrip cloth which is sandwiched between 2 strainers.
8. Check the cloth carefully on top of a light box. If no insects are found, rinse and enjoy. If an insect is found, repeat steps 6-8. If insects are found after performing these procedures 3 times, the produce is overly infested and should be discarded.

MILK SUBSTITUTES, NUTRITIONAL SUPPLEMENTS, AND INFANT FORMULAS

The OU has researched the following milk substitutes, nutritional supplements, and infant formulas, and has determined that they are respectively suitable for someone who is infirm (*choleh she'ain bo sakanah*) and for infants, when bearing the OU logo.

Most of these products contain *kitniyos*, and for some that is the primary ingredient. Accordingly, consumers should consult with their rabbi before deciding to use these items which are not fully kosher for Pesach. With the exception of the flavors used, any item which might be *chametz*-based is used in such small proportions that it is *batel b'shishim* (nullified). Where possible, it is preferred to (a) use a substitute which is certified for Pesach, and (b) use a liquid supplement instead of a powdered one. Products should be purchased before Pesach and be maintained segregated from kosher for Pesach foods.

PESACH PET FOOD



On Pesach, a Jew may not eat, own, or derive benefit from *chametz*, but he may own and have benefit from *kitniyos*. Accordingly, in addition to year-round concerns about meat and milk ingredients in the same product, pet food must be free of *chametz* if one will own or use it on Pesach. The following are pointers to help you read the pet food's ingredient panel to determine if there is any *chametz* present.

1. In addition to checking for the five *chametz* grains – wheat, barley, rye, oats, and spelt – also look for brewer's yeast, malt, pasta, xanthan gum, and other generic terms which may refer to a *chametz* ingredient (e.g., flour, gluten, middlings, starch, et al.). If any of these are present, you should not own or use this pet food on Pesach.
2. Many varieties of pet food contain a multitude of vitamins and minerals. Although there is a chance some might be *chametz*, they typically comprise such a small percentage of the food that they are *batel*, and do not pose a concern.
3. Some common ingredients which do **not** pose a Pesach concern are:
 - A. **Animal, poultry, and fish** products.
 - B. **Vegetables**, such as alfalfa, asparagus, beets, and carrots.
 - C. **Assorted *kitniyos* foods**, such as buckwheat, corn products, lentils, millet, peas, rice, peanuts, sunflower seeds, and soy products.
 - D. **Other items**, such as barley grass, BHA, BHT, carrageenan, cellulose, colors, eggs, gums (other than xanthan gum), kelp, lactose, linseed, milk products, molasses, oils, psyllium, and whey.

Be aware that **mealworms**, which, as living creatures are not *chametz*, are commonly sold in a bed of wheat flakes or oatmeal, which is *chametz*.

Whole insects (live or dead) with no additives or other ingredients are permissible.



PESACH FAQs

MEDICINE & COSMETICS

Alcohol

Q I know that alcohol can be made from wheat. What about things like isopropyl alcohol?

A Benzyl alcohol, methyl alcohol (a.k.a., methanol), isopropyl alcohol and stearyl alcohol are not made from *chametz*. Ethyl alcohol, a.k.a. ethanol, can be made from *chametz*, and isoamyl alcohol is often a byproduct of whiskey. [These might be listed as part of a compound, like ethyl acetate or isoamyl butyrate.] So, they're not recommended unless they are known to be *chametz*-free.

There are different opinions about whether denatured alcohol (SD alcohol) is forbidden on Pesach. The cRc position is that it's permitted in a product manufactured in the United States.

Toothpaste

Q Is it okay to use my regular toothpaste on Pesach?

A Some *poskim* hold that toothpaste is considered inedible, since any food that tastes like toothpaste would never be served as a meal item. This is the justification for why many rabbis allow the use of any toothpaste (year-round) despite the possibility that the glycerin contained in the toothpaste is made from non-kosher animal fat. Others argue that toothpaste is halachically considered edible, since we put toothpaste into our mouths every day (and young children like to eat it). Some follow that position all year round and will only use a toothpaste that is certified as kosher (or free of glycerin).

The cRc accepts the lenient approach as relates to year-round use but recommends that one be *machmir* for Pesach – that you should only use a toothpaste that's known to be *chametz*-free.

What ingredients in toothpaste might be *chametz*? Just about every variety of toothpaste has sorbitol, which is created by "hydrogenating" glucose, which can be derived from *chametz*, *kitniyos*, or completely innocuous ingredients, and though most glucose and sorbitol in the U.S. is not made from *chametz*, we can't recommend toothpaste unless we know what the glucose is made from. Toothpastes also commonly contain other minor ingredients which raise *chametz* concerns.

Contact Lens Solution

Q Do I need special contact lens solution for Pesach?

A We reviewed the ingredients used in several popular brands of contact lens solution and didn't see anything which was sensitive for Pesach. Some brands are listed in the Medicine Guide and others can be found in the eye product checker on our website. But since we haven't checked every brand, you're welcome to send a picture of the ingredient panel to info@crckosher.org, and one of our rabbis will check on it for you.

Hand Sanitizer

Q Do alcohol-based sanitizers require Pesach certification?

A Alcohol-based hand sanitizers, like Purell, usually have at least 62% ethyl alcohol, which may possibly be *chametz*. However, Rav Gedalia Dov Schwartz zt"l checked a sample of hand sanitizers and said that it's as inedible as other liquid soaps and may, therefore, be used on Pesach, regardless of the source of alcohol. [An additional factor to consider is that the alcohol used in the hand sanitizers is denatured.]

Steamers

Q Can I kasher my countertops with a steamer?

A The general rule (as per *Iggeros Moshe* YD 1:60) is that *kashering* must be done with water in liquid form, and can't be done with steam. So, a steamer can only be used for *kashering* if two conditions are met. First, the steam must condense to the point that the whole area being *kashered* is covered with water, and second, that water must be at approximately the boiling point (212°F). Most steamers sold for cleaning purposes do not meet these criteria and can't be used for *kashering*, but the Wagner Power Steamer 715 can be used, if one is diligent to use it slowly and with patience.

Consumers who hire outside companies to kasher should verify the qualification of both the service providers and the equipment.

SHOPPING GUIDE

Bottled Water

Q Is bottled water acceptable for Pesach without special certification?

A Yes, and this is true even if the water also has these minerals: calcium chloride, magnesium chloride, magnesium oxide, magnesium sulfate, potassium bicarbonate, potassium chloride, sodium bicarbonate, or sodium chloride. But if it has any vitamins and/or citrates (e.g., calcium citrate), then it should only be used with kosher for Pesach certification.

Buy Before Pesach

Q I see that you recommend certain items for Pesach but say they should be bought before Yom Tov. If they do not contain any *chametz*, why can't I also buy them on Chol HaMoed?

A There are a handful of items – milk, eggs (in the shell), bagged salads, baby carrots – where (a) additives are used which might be *chametz* (although they probably aren't), (b) the additives are *batel b'shishim*, but (c) they're in stores very soon after they're processed. So, the milk, eggs, etc., which you buy on Chol HaMoed might have been produced on Pesach with a *chametz* additive which can't be *batel* (since it was added on Pesach). This is why we recommend that if these items aren't available with Pesach certification, you should buy them before Yom Tov.

Contradictory Certifications

Q I saw a package that had two kosher certifications on it. Next to one it said, "Kosher for Passover," and near the other one it said, "Kosher for Year-round Use and Not for Passover." Which one is it?

A Most of the time, this is because the two *hashgachos* disagree about a point of halachah or policy. For example, some rabbis allow the use of quinoa on Pesach, while others consider it *kitniyos*. The agency which marks the product as "Kosher for Passover" took the lenient position, and the other agency disagreed and took the stricter decision. Your rabbi should be able to figure out what the point of difference is and then direct you as to which of these opinions you should follow.

Seltzer

Q Why does the cRc require a Pesach *hechsher* on unflavored seltzer?

A There are several ways to collect the carbon dioxide used to make seltzer. One source is a byproduct of beer or whiskey production. And of course, beer and (just about all) whiskey are *chametz*. There's a difference of rabbinic opinion about whether the *chametz* status transfers to the carbon dioxide gas. Some say that since carbon dioxide is a gas, and it is "scrubbed" of all *chametz* taste, it's permitted on Pesach, despite the *chametz* source. The cRc follows the stricter opinion that treats the gas as *chametz*, since it's a direct result of the beer or whiskey production.

KASHERING

Induction Cooktop

Q How can I *kasher* my induction cooktop for Pesach?

A Induction cooktops don't have a heating coil or other heat source, so there's no realistic way to *kasher* them. The only way to use the induction cooktop on Pesach is to put a physical barrier between the cooking surface and the pots. This can be done either with "induction discs" (widely available to help people cook on an induction surface with pots that are not ferromagnetic) or a "mat" that's designed for an induction cooktop. Although the cooktop won't have been *kashered*, the barrier prevents any absorbed *chametz* from spreading to the pots and food.

On a related note, using an induction cooktop raises significant *halachic* issues on Shabbos and Yom Tov

[some of which might be eliminated by the use of the induction discs noted above], and consumers should consult with their rabbi for guidance.

Iron for Kashering

Q My son suggested we *kasher* our countertops by running a hot iron over them. Would this work?

A A counter can't be *kashered* with a clothing iron without any water present. Theoretically, hot water could be poured on the counter, and then the iron could be used to bring that water to a boil, but because it would be too difficult to know whether every single part of the countertop came into contact with boiling water, we wouldn't recommend it.



SEDER DIETARY NEEDS

A Brief Guide

At the Pesach Seder, a person is required to eat a considerable amount of food and beverages, some in a relatively short amount of time. This poses a challenge for many people who have dietary restrictions. This article will give brief guidelines on options or minimums for the *daled kosos*, matzah, and *marror*. Further details, including suggestions for other challenging elements of the Seder, are available in the full-length article available at crckosher.org/pesach.

As with all matters of halachah and medicine, each person should consult with their rabbi and doctor or RDN before making a final decision.

Daled Kosos

At four points in the Seder, a person must drink from a cup of wine or grape juice.

1. The cup must hold 2.9 ounces, and the person must drink at least half of that amount.
2. For those who should not even drink that much wine or grape juice, they can dilute the beverage with up to 50% water, thereby minimizing the amount of alcohol or sugar they will consume.
3. Those who can only swallow thickened beverages should use one that is nectar-thick or honey-thick, but not one which is pudding-thick. (Thickener and thickened juice require special Pesach certification.)

Matzah

There are three times at the Seder when we are obligated to eat matzah – *Motzi Matzah*, *Korech*, and *Afikomen*. The standard amount required at each of these points (using hand *shemurah* matzah) is shown in the following chart. If it is medically advised that a person not consume that much matzah, then a rabbi should be consulted who may advise that it is acceptable to eat less than these amounts.

	MOTZI MATZAH	KORECH	AFIKOMEN
Thin Matzah	8 x 7 inches	3.5 x 7 inches	7 x 7 inches
Average Matzah	7.5 x 6 inches	3.5 x 6 inches	6.5 x 6.5 inches
Thick Matzah	8 x 5 inches	3.5 x 5 inches	7 x 5 inches

Rema records a custom to only use wheat-based matzah at the Seder. However, if a person is allergic to wheat or prefers spelt or rye matzah, it is permitted to use a different type of matzah. Similarly, those who are celiac have no choice but to use gluten-free oat matzah at the Seder. (Egg matzah may not be used at the Seder.)

Those who cannot chew or swallow standard matzah should either use ground matzah or soak matzah briefly in ambient temperature water before eating it. If neither of these suffices, one should consult with a rabbi for other possible options.

Marror

The amount which must be consumed for *Marror* is the amount which will fill up a 1-ounce shot glass when pressed tightly into the glass leaving no empty air spaces. If this poses a health challenge, a rabbi should be consulted for guidance. (Cooked vegetables may not be used as *marror*.)



SEFIRAS HAOMER CALENDAR 2026



Sefira is the counting of seven complete weeks from the second evening of Pesach until Shavuot. The count, which takes place after nightfall for the following day, is preceded by the following *bracha*, only if done in the evening and no days have been missed in the count.

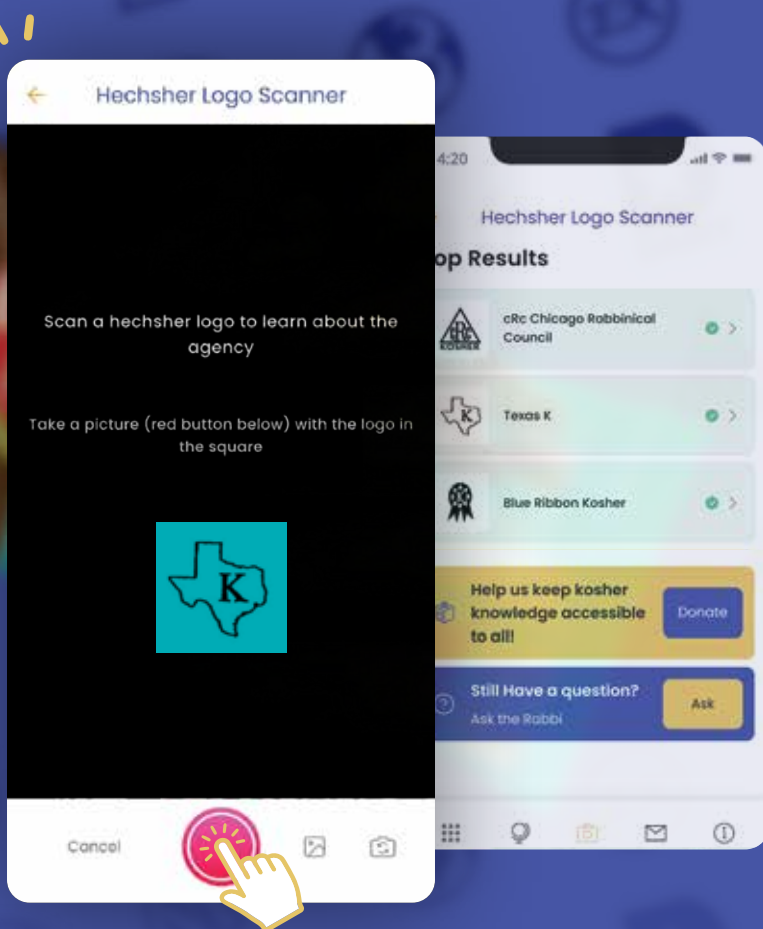
